

WHEREAS THE SETTLOR above named is desirous of creating a trust by setting apart and establishing a fund for the Public Religious and Charitable objects and purposes in India herein after expressed.

AND WHERE AS THE SETTLOR above named has settled an initial contribution of a sum of **Rs. 50000/-** (Rupees Fifty Thousand only) in favour of the **TRUSTEES** upon Trust with a view to give effect to his desire of creating and establishing a Trust for the purpose of charitable activities in India for the benefit of the public, for the objects set out in this trust deed and for fulfillment of which, the terms and conditions are more particularly set out hereunder and Trustees have accepted the same to be held by them upon the Trust hereinafter mentioned.

AND WHEREAS THE TRUSTEES named are willing to accept the office of the Trustees of these presents and to hold the said sum of **Rs. 50000/-** (Rupees Fifty Thousand only) **TO HAVE AND TO HOLD** the same and all other sums and property absolutely and forever upon Trust for the purpose of carrying out the wishes of the **SETTLOR** of the Trust subject to the powers, provisions, stipulations, declarations and directions set forth herein, so as to enable to pursue its vowed objects and the **SETTLOR** of the Trust hereby relinquishes for all time any claim to or interest in the said assets and properties or fund forming the subject matter of the Trust and the **SETTLOR** of the Trust hereby relinquishes for all time any claim to or interest in the said assets and properties or fund forming the subject matter of the Trust.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS

- 1) The **SETTLOR** above named hereby establishes a Public Charitable Trust by the name of **SOHO BHARAT FOUNDATION** for the purpose and upon the conditions set forth hereunder.
- 2) The office of the Trust for the time being shall be at **216, KARNANI MANSION, 25/A, PARK STREET, KOLKATA-700016**, with the power given to the Trustees to shift the same to any other place as they may mutually agreed upon.
- 3) The **TRUSTEES** named above shall be the first trustees and have given their consent to be appointed as the trustees and as taken thereof, they have set their hands to this instrument.
- 4) The Trust fund shall be utilized for relief of the poor, education, medical relief, religious activity and for the advancement of general public utility in India not involving any activity carried out for profit.
- 5) The trustees will have power to utilize the income and / or corpus of the Trust Fund for all or any of the said purposes as they may at their absolute discretion determine and without prejudice to the generality of the said powers.
- 6) The Trustees will have further powers in advancement of the aforesaid purposes without any distinction of caste, creed or sex.
- 7) The **SETTLOR** hereby conveys, transfers and assigns to the **TRUSTEES** the above referred sum of **Rs. 50,000** (Rupees Fifty Thousand only) as corpus to the **TRUST**, the receipt of which, the **TRUSTEES** do hereby admit and acknowledge.

8) The **TRUSTEES** do hereby agree that they shall hold and stand possessed of the said trust assets, properties and funds (which expression shall include all investments in cash or kind or in any nature whatsoever into and for which, the said property or a part or parts thereof may from time to time be converted, varied or exchanged) and/ or such investments as may be held by the **TRUSTEES** from time to time in relation to these presents together with all income, profits, additions and accretions thereof, upon trust for the object set out herein with and subject to the provisions and conditions hereinafter contained in these presents.

1. OBJECTS:

The objects of the Trust are:

- a. To establish, promote, set-up, run, maintain, assist, or aid to or help in the setting up and/ or maintaining social homes or other establishments for relief and/or help to the poor, old and infirm people and/or destitutes.
- b. To provide food, clothing and / or shelter to poor persons and to give alms to them either in cash or in kind or otherwise.
- c. Construction and running of schools, colleges, education institutions, free dispensaries, center for poor feeding and homes for the aged for the benefit of the public.
- d. To give, provide and/or render help and assistance to and/or implement any scheme for providing livelihood and upliftment of the poor farmers.
- e. To start, maintain and assist any relief measures in those parts which are or become subjected to natural calamities such as flood,

fire, drought, famine, cyclone, earth-quake, epidemic, storm, accident etc.

- f. To open, establish, promote, set-up, run maintain, assist, finance and support and/or aid or help in the setting up and/or maintaining and/or running hospitals, boarding houses, reading rooms, gymnasium and other training and vocational institutes.
- g. Providing for grants, scholarships, fellowships and other forms of financial assistance to the needy and deserving students for pursuing education, vocational training, skill development etc.
- h. Granting of financial assistance to any educational institution for granting scholarships, prizes, medals, awards for excellence in studies, sports and scientific research, distribution of books and note books for poor and deserving students.
- i. Promoting, advancing and encouraging primary, secondary and higher education including medical education, physical training, training of other useful arts, crafts among public including the establishment and maintenance of kala-kendras and other welfare centres for them.
- j. To open, found, establish, promote, maintain or help in setting up establishment, maintenance and/or running dharamsalas, tanks, roads etc.
- k. To promote, organize, maintain and/ or grant aid to any person, institution or society whatsoever having for its objects of charitable purposes and to incur expenditure in connection therewith.
- l. To grant aid or donation money to any fund, object or institutions established or engaged for advancement of any public charitable

purposes within the meaning of Income Tax Act 1961, or any amendments made thereunder

- m. Providing relief to the poor and advancing any other object of general public utility.
- n. The Trust will not carry out any activities with the intention of earning profit and will perform with service motive only.

2. AREA OF OPERATION:

It is expressly declare that the Trust shall carry out its activities within the territorial jurisdiction of India and no part of the Trust property or its income or Trust Fund shall be applied for any purpose outside India and for any purpose which is not a public charitable purpose in law and all provisions hereof shall be construed accordingly.

3. PROHIBITION:

- a. That none of the objects of the trust shall at any time involve caring of any activity for profit.
- b. That the income or assets of the trust fund shall not be applicable or transferred at any time in whole or in part for any purpose, service of the mankind and its welfare purpose.
- c. That the income of assets of the trust shall not be applied or used for the benefit of the authors of the trust, or any person who make substantial contributions or donations of the trust or any trustee or manager of the trust.

4. BENEFICIARIES OF THE TRUST:

The Trust is established for the benefit of citizens of India and the class of people mentioned above without discrimination of caste, religion, creed or sex.

5. BOARD OF TRUSTEES:

The Trust will be managed by a **Board of Trustees** consisting of not less than 2 trustees and not more than 9 trustees. The parties of the Second Part will be First Trustees and they shall automatically form the Board of Trustees

The financial year of the trust shall end on 31st march, every year provided that the Board of Trustees shall be at liberty to change the same from time to time if they so deem it fit and proper,

The first **Managing Trustee** shall be the **SETTLOR** and he will hold office for his life time. After the demise or relinquishment of office of the Managing Trustee or in the event of the first Managing Trustee failing to nominate his successor in office, the remaining trustees shall elect one of the other Trustees as Managing Trustee.

The term of office of First Trustees shall be for their respective lives. The Board of Trustees shall have the power to increase the total number of Trustees upto the maximum number stated above and fix their term as per provisions contained herein.

Any Trustee, including the Managing Trustee may retire from the Trusteeship hereof by giving two calendar months notice in writing of his or her intention to do so, to the Board of Trustees and after the expiry of the period of notice, the Trustee giving the notice shall ipso facto cease to be a Trustee of these presents.

The Trustees who are not First Managing Trustee or First Trustees shall hold office for a period of one year from their date of

appointment by the Trustees. At the end of this one year period, the Board of Trustees may reappoint them for subsequent term or appoint other persons as Trustees in such a manner that the total number of Trustees does not exceed the approved maximum number of Trustees.

The proceedings of the Board of Trustees shall not in any way be invalidated due to any post or posts remaining vacant. During the time when a vacancy is yet to be filled up, the remaining Trustees shall act as **"Full Board"**, subject to the presence of Quorum in the meetings. Any vacancy in the Board of Trustees or illegality in the appointment of Trustees or their proceedings shall not invalidate any prior act or decision of the Board.

The Trustees shall from time to time after meeting the expenses of and incidental to the management of the Trust properties and of Trust decide the particular object for which the income or corpus of the Trust Fund or properties for the time being available shall be applied.

The Trustees may accept any donation or contribution in cash or in kind from any person, firm, company, corporation, associations or trust (including the SETTLOR or the trustees or any of them) for the furtherance of the objects of the trust or for any one or more of them upon such conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the trust.

6. CESSATION AND DISQUALIFICATION OF MEMBERS AND TRUSTEES:

- I. Following persons shall be disqualified from becoming members and trustees:
 - a. Persons of unsound mind.
 - b. Insolvents and bankrupts.

c. Persons convicted on charges of moral turpitudes by any competent court.

II. A trustees shall vacate office and a member shall cease to be a member in the following events:

- a. Resignation or death.
- b. Removal (as provided hereafter).
- c. Becoming disqualified under clause 1) above.

III. REMOVAL OF THE TRUSTEES:

The trustees for the time being by three fourth majority resolve that the continuance of any trustees is prejudicial to the interest of the trust or a resolution by the circulation, approved by 3/4th majority of trustees members for the time being after having given such affected trustees a reasonable opportunity of being heard and after considering his representation . If any the trustees about whom the resolution is adopted shall be deemed to have been removed.

IV. VACANCY IN THE BOARD OF TRUSTEE:

If any vacancy arises in the Board of Trustees, on account of death, incapacity or persistent neglect of any trustee, the remaining trustees may co-opt any person preferably out of the personnel of the society, provided, however that no such trustee shall be co-opted if the society by its three fourth majority does not approved of such selection.

7. TRUST ADMINISTRATION, FUNCTION AND POWER TO THE BOARD:

Without affecting the generality of powers and functions of the Trustees to manage and administer the trust, the Board of Trustees shall have the following **functions**:

- a. To administer the Trust, its properties and affairs and do all the things which will fulfill the performance of the objects for which the Trust is established and for this purpose the Board can apply the whole or any part of the Trust property towards the payment of the expenses of the Trust.
- b. To borrow if needed against the security of the assets of the trust by way of bank overdrafts, loan or otherwise, as may be necessary, for the benefits of the trust and for more effectively carrying out the objects of the trust provided however the trustees unanimously agree on such borrowing and limited to the terms of their decision or agreement and to authorize two or more of the trustees to execute such documents, deeds etc. as may be necessary in connection therewith.
- c. The Trustee shall cause true and accurate accounts to be kept of all monies received and disbursed or spent as well as of all the assets, credits and effects of the Trust properties and shall maintain proper record of all decisions resolutions etc. found necessary to be taken in course of management of Trust properties or in respect thereof or in relation to the carrying out the objects and purposes of the Trust.
- d. The income and the properties of the Trust will be solely utilized towards the objects of the Trust and no portion of it will be utilized for payment to the Settler, or Trustees or their relatives by way of salary, allowances, profit, interest, dividend etc.

- e. To open one or more bank accounts and operate the same or provide for operation of the said accounts by any two among them authorized on their behalf.
- f. To invest the Trust funds in the manner not prohibited by any provisions of the Income Tax Act, 1961.
- g. To execute power of attorney or powers of attorney to any person for the purpose of executing, administering or managing the whole or any part of the Trust for the purpose of all or some among the objects of the Trust.
- h. To borrow money with or without security and to repay the same.
- i. To receive, collect and enforce recovery of all monies due or payable to the Trust and grant receipts and discharges therefore.
- j. To settle, compromise or compound any disputes or refer the same to arbitration or litigation.
- k. To receive voluntary contributions from any person or persons from India or outside, after complying with the statutory formalities, by way of donation, gifts or in any other manner and to hold the same upon Trust for the objects set forth herein.
- l. To appoint, suspend, dismiss or otherwise deal with the staff required for the administration of the Trust, to frame rules relating to their salaries and other benefits and generally to exercise all powers ancillary and incidental to effectively carry out the objects of the Trust.

- m. The Board shall have power to make and rescind rules and regulations for the management and administration of the Trust.
- n. No Trustee shall commit any act or breach of Trust of the Trust fund or property or cause any loss to the Trust property or commit fraud in the administration of the Trust fund / property.
- o. The Board of Trustees will follow the instructions given by any donor who makes substantial contribution towards furtherance of the objects of the Trust, so long as such instructions are not detrimental to the attainment of the objects of the Trust and are in conformity with the provisions of the Income Tax Act, 1961.
- p. The Board of Trustees may appoint Secretaries, Managers, Lawyers, Solicitors, Auditors, Architects, Engineers or other employees for the purpose of management and supervision of the Trust Estate, for collection of rent, effects and profits, for keeping the accounts and records and for other purposes of the trust.
- q. The trust will never do acts which are illegal and unlawful in nature and also oppose to the public policy and contrary to the law of the country in connection with Section 4 for which the trust and the trustees are responsible for that and come under all punishable Law (CRPC and IPC).
- r. The trust will never do acts like Micro Financing and Money Laundering Act, 2012, Economic Offence/crime in connection with Section 20 and in nature and shall not obtain any donation or like that from abroad without getting permission of FCRA ACT, from the central Government/ the competent government

authority, which the trust and the trustees are responsible for that and under all the punishable Law (CRPC and IPC).

8. MEETING OF THE BOARD OF TRUSTEES:

The Board of Trustees should meet atleast once in every calendar quarter and may meet more often when required.

- a) The meeting of Board of Trustees shall be convened by the Managing Trustee and he shall preside over the meetings. In his absence, any of the Trustees present in the meeting may elect one amongst themselves to be the Chairman of the meeting.
- b) Minimum of two trustees shall constitute the QUORUM for the Board of Trustee meetings.
- c) All decisions shall be carried out by the majority decision of the Board but in the event of equality of votes, the Chairman presiding over the meeting shall have a casting vote.
- d) Any resolution in writing signed by all the Trustees by circulation shall have equal force as though it has been passed at a meeting of the Board of Trustees.
- e) The meeting of the Board shall be conveyed after giving at least a week's notice unless all the Trustees agree to accept a shorter notice.
- f) All meetings of the trust shall be held at such place and at such time as the chairman of the trust shall decide from time to time.
- g) The Board of Trustees may invite other persons interested in the objects and functioning of the Trust to attend the meetings of

the Board, but they shall not be entitled to vote in the meetings of the Board.

- h) A trustee who is unable to be present at a meeting of the trustees may send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matter concerned.

9. BANK ACCOUNT:

One or more Bank Accounts may be opened in any Bank and or Banks in the name of the Trust. The operating instructions shall be as per resolutions passed in the meeting by board of trustees from time to time.

10. INVESTMENT OF TRUST FUNDS:

- a) The Board shall also determine from time to time, the amount it shall spend on the various activities of the Trust.
- b) All the funds, monies shall be invested by the Trust in eligible securities, investments or shall be kept in bank in terms of the provision of section 11(5) of the Income Tax Act 1961.
- c) The trustees shall invest the trust fund in Government Securities, Savings Certificate, Fixed Deposit or any other form of Investment Authorized under provision of Indian Income Tax Act 1961 as they shall deem expedient.

11. ACCOUNTS AND AUDIT:

- a) The financial year of the Trust shall be from 1st April to 31st March of the following year, unless otherwise decided by the Board of Trustees.

- b) The Board of Trustees shall maintain true and correct accounts of the Trust.
- c) The accounts of the Trust shall be annually audited by a Chartered Accountant appointed by the Board of Trustees and the audited statement of account shall be placed before the Board for its approval within three months of the close of the financial year.

12. AMENDMENTS:

- a) While this Trust shall be irrevocable, the Board of Trustees may amend or alter any of the clauses except those relating to objects of the Trust, the First Managing Trustee and First Trustees, at a duly convened meeting of the Board with at least 2 weeks' notice, and by a resolution passed by atleast three-fourths majority of the Board of Trustees present and voting. The amendments to the Trust deed can only be passed by a resolution of the Board of Trustees in an actual meeting and not by circulation.
- b) If any alteration or amendment is necessary, the same shall be affected through supplementary deed/deeds with the previous approval of the Commissioner of Income Tax and these shall be read together with the main Trust deed.

13. INDEMNITY:

The Board of Trustees shall be indemnified for any act done by them in good faith in the course of the administration of the Trust.

14. SETTLOR AND THEIR RELATIVES:

Notwithstanding the powers vested with the Trustees under the proceeding clause, no part of the income of the Trust shall benefit directly or indirectly the trustees and no part of the income of the property of the Trust shall be used or applied directly or indirectly for the benefit of:

- (a) **Settlor, Managing Trustee, Trustees** or any person who makes a substantial contribution to the Trust or of any relative of the **SETTLOR, Managing Trustee, Trustees** or the person who makes a substantial contribution.
- (b) Any **“related concern”** in which any of the above persons has substantial interest.
- (c) For the purpose of this clause, the word **“relative”** and the phrases **“related concern”**, **“substantial interest”** and **“substantial contribution”** shall have the meanings assigned to them in the Income Tax Act, 1961.

15. APPLICATION OF TRUST ACT:

The provisions of the Indian Trust Act 1882 shall apply to all matters not specifically mentioned in these presents.

16. APPLICATION OF INCOME TAX ACT:

All clauses herein are intended to secure exemption from Income Tax on the income of contributions and donations to the Trust and any clause or portion of this Deed of Trust which is inconsistent with or repugnant to the sections of the Income Tax Act, 1961 as amended, substituted or modified from time to time, shall be deemed to be deleted or modified with effect from

the date on which the sections to which the clause or part of a clause is repugnant or inconsistent comes into force.

17. THIS TRUST IS DECLARED IRREVOCABLE

18. DISSOLUTION:

If Trustees shall be unanimously on the opinion that the Trust be dissolved such resolution shall be effected by an instatement in writing under their hands and if, met all the due and provision of the Trust have been paid / provided for, if there shall remain any assets shall be transferred to another Charitable Trust, Society, Association of Institution or Institutions having aims or objects which in the opinion of the Trustees are similar to those of this trust and which enjoys recognition u/s 12A of the Income Tax Act, 1961.

19. AMALGAMATION:

The trustees may amalgamate the trust with any other Charitable Trust or Institution having similar objects with prior permission of the Concerned Authorities under any law as may be applicable for the time being.

20. SAFE CUSTODY OF IMPORTANT DOCUMENTS:

All securities, investments bonds, title deeds etc, relating to the Trust estate shall be kept in the safe custody with the Trustees or Bankers(s) of the trust.

21. Trust Property:

At present the trust has no immovable and landed property save and except the trust value amounting to Rs. 50,000/- (Rupees Fifty Thousand Only) in its own name and no immovable and landed property is being settled in favour of this trust by this document.
